### PARADE GUIDELINES

#### **Line-up:**

All regular units may start lining up on S. Ann St. at 4:00 p.m. on a first-come basis with no assigned spots. Float riders may not park their vehicles on S. Ann St. or at the City Hall parking lot.

Riders on a float that is **already** lined up may be dropped off at City Hall **and walk** to their parade units. However, the vehicle bringing them may not remain in the City Hall parking lot.

The contact person listed on the entry form is responsible to notify all float riders and drivers about line-up rules.

Police units, elected official and color guards, will line up in the City Hall parking lot.

Fire engines will line up on N. Pearl St. which is on the east side of City Hall.

## PARADE GUIDELINES (continued)

**Walkers:** Must park their vehicle on North St. Walkers accompanying a parade unit must stay with their unit.

**Generators / Fire Extinguishers:**

Generators must be able to run for at least 1 hour. Those used in conjunction with float lighting must be securely mounted on a vehicle or another substantial base. A minimum of 12 inches clearance must separate any part of the generator from the lights, any combustible fabrication or decorating material. At least one 5-pound dry chemical or 10-pound carbon dioxide fire extinguisher should be placed within easy reach of the float driver and at least one near each generator.

**Parade Route:** The parade starts promptly at 6:00 p.m. Police units, elected official and color guards enter the parade first followed by Fire Department vehicles. Regular parade units lined up on S. Ann St. will then enter the parade route.

The undersigned has read and voluntarily signed this Release, Waiver of Liability and covenant not to sue and agrees to be bound by its’ terms.


