Opening Agenda

1. Call meeting to order.

With a quorum of the Council Members present, the Regular Meeting of the Rockport City Council was called to order by Mayor Pro-Tem Hattman at 6:32 p.m. on Tuesday, July 12, 2022, in the Training Room of the Rockport Service Center, 2751 State Highway 35 Bypass, Rockport, Texas.

2. Pledge of Allegiance.

Mayor Pro-Tem Hattman led the Pledge of Allegiance to the U.S. flag.

3. Citizens to be heard.

At this time, comments limited to three (3) minutes will be taken from the audience from persons who have signed the speaker's card located on the table in the back of the Training Room of the Service Center and delivered to the City Secretary before the meeting begins, or written comments received by 4:00 p.m. on the day of the meeting, on any subject matter that is not on the agenda, will be read and summarized in the minutes of the meeting. Persons wishing to address the Council and who have registered using the Citizen Participation Form will have up to three minutes to speak. In accordance with the Open Meetings Act, Council may not discuss or take action on any item that has not been posted on the agenda. While civil public criticism is not prohibited, disorderly conduct or disturbance of the peace as prohibited by law shall be cause for the chair to terminate the offender's time to speak.

There were no citizen comments.

Consent Agenda

- 11. Deliberate and act to approve the placement of a directional sign for the Fulton Mansion to be placed on Maple Street and Broadway Street.
- 12. Deliberate and act on Resolution authorizing the City Manager to prepare, post, and publish for sale the previous location for City Hall being Lot E/2, Block 2, Doughty and Mathis Outlots Outlot 3, also known as 622 E. Market Street.

Mayor Pro-Tem Hattman called for requests to remove any item from the Consent Agenda for separate discussion.

Council Member Brundrett requested Consent Agenda Item 9 be pulled for separate discussion.

MOTION: Council Member Hale moved to approve the Consent Agenda Items minus Item 9, as presented. Council Member Jackson seconded the motion. Motion carried unanimously.

Item 9.

Council Member Brundrett said he wanted to make sure everybody was okay with the appointments and workload.

Mayor Jayroe said he tried to distribute the appointments as evenly as possible.

MOTION: Council Member Jackson moved to approve Consent Agenda Item 9. Council Member Brundrett seconded the motion. Motion carried unanimously.

Regular Agenda

13. Deliberate and act on second & final reading of an Ordinance amending Chapter 50 Division 4 "Flood Hazard Reduction" of the Code of Ordinances, City of Rockport, Texas, in order to be compliant with Community Rating System requirements; repealing all ordinances to the extent they are in conflict; providing for severability; and providing an effective date.

Community Planner Carey Dietrich said there had been no changes in form on content since Council approved the first reading of the Ordinance on June 28, 2022.

MOTION: Council Member Jackson moved to approve the second & final reading of an Ordinance amending Chapter 50 Division 4 "Flood Hazard Reduction" of the Code of Ordinances, City of Rockport, Texas, in order to be compliant with Community Rating System requirements; repealing all ordinances to the extent they are in conflict; providing for severability; and providing an effective date. Council Member Brundrett seconded the motion. Motion carried unanimously.

14. Hear and deliberate on proposed amendment to Chapter 106 of the City of Rockport Code of Ordinances, to update the current Tree and Landscape Ordinance.

Community Planner Carey Dietrich stated there have been many revisions to the proposed amendment.

Mayor Pro-Tem Hattman asked why there was not a provision in the proposed amendment that would allow funds to be used to purchase property for greenspace.

Council Member Brundrett said he thought we already had that in the City's development standards.

Public Works Director Mike Donoho stated Mr. Brundrett was correct that the City does have in the development standards that when a property is developed, they can designate a greenspace area.

Interim City Manager Richard Morton asked City Attorney Bastian-Rodriguez if language can be added that would allow the City to spend funds for green space maintenance or purchase.

City Attorney Bastian-Rodriguez said she was not sure but she would research it and follow-up with staff.

Ms. Dietrich said if the City Attorney tells staff this is allowable, she will add the language to the proposed amendment.

15. Deliberate and act to re-appoint and appoint members to various City of Rockport boards, committees, and commissions.

Mayor Jayroe said he did try to spread out appointments throughout all wards.

City Secretary Teresa Valdez stated under the listing for the Zoning Board of Adjustment and Building & Standards Commission Matthew Grimes is shown in red type as a re-appointment and it should be shown in blue type as a new appointment.

Ms. Valdez read the list of re-appointments and appointments for each of the boards, committees and commissions.

Council Member Jackson stated July 4th was a success and the Art Festival made a lot more at the gate this year. Council Member Jackson thanked everyone for supporting the Second Saturday in downtown.

Council Member Hale thanked Director of Finance Katie Griffin and City staff for the hard work and information provided in the Budget Workshop this afternoon.

Council Member Brundrett said there had been another successful July 4th in Rockport and the Police Department did not have any big issues. Council Member Brundrett said the Art Festival and the live auction was great and well attended. Council Member Brundrett thanked staff for working on the budget and the Workshop this afternoon was painless. Council Member Brundrett thanked Aransas County and the Public Works Department for the road base materials that have been placed in various locations.

Mayor Pro-Tem Hattman thanked staff for the budget presentation this afternoon. Mayor Pro-Tem Hattman thanked the Police Department for their hard work during the 4th of July.

Mayor Jayroe also thanked the Police Department for their hard work during the 4th of July. Mayor Jayroe said he has never heard so many nice things in the 30 years he served as a police officer. Mayor Jayroe said the City is working on the Rockport Country Club drainage plans.
