***** PLEASE READ LETTER BEFORE CALLING THE MUNICIPAL COURT *****

This letter is furnished as a courtesy to you by the Municipal Court of Rockport, TX to assist you in making a disposition of the charge(s) filed against you. THE JUDGE CANNOT DISCUSS YOUR CASE PRIOR TO TRIAL.

_____ I HEREBY ENTER A PLEA OF NOT GUILTY AND DESIRE A TRIAL. THE COURT WILL NOTIFY YOU WHEN YOU MUST APPEAR FOR TRIAL. YOU HAVE THE RIGHT TO A TRIAL BY JURY, IF YOU SO REQUEST. _____ (TRIAL BY JUDGE) OR (TRIAL BY JURY), _____. FAILING TO APPEAR FOR TRIAL MAY RESULT IN A WARRANT BEING ISSUED FOR YOUR ARREST.

_____ I HEREBY ENTER A PLEA OF GUILTY OR NOLO CONTENDERE. A PLEA OF NOLO CONTENDERE MEANS THAT YOU DO NOT CONTEST THE STATE'S CHARGE(S) AGAINST YOU. THE FINE FOR A NOLO CONTENDERE PLEA IS THE SAME AS A PLEA OF GUILTY. EITHER PLEA INDICATES THAT YOU AGREE TO WAIVE APPEARANCE BEFORE THE COURT FOR TRIAL.

_____ I HEREBY ENTER A PLEA OF NOLO CONTENDERE AND REQUEST DRIVER'S SAFETY COURSE. ALL REQUESTS FOR DRIVER'S SAFETY COURSE MUST BE IN PERSON OR IN WRITING. I LOSE THE RIGHT TO REQUEST FOR DSC IF NOT DONE BY APPEARANCE DATE. I POSSESS A VALID TEXAS DRIVERS LICENSE OR PERMIT. CDL DRIVERS NOT ELIGIBLE FOR DEFENSIVE DRIVING. I HAVE NOT TAKEN A DRIVER'S SAFETY COURSE IN LIEU OF PAYING A FINE DURING THE PAST 12 MONTHS. I AM NOT IN THE PROCESS OF TAKING A DRIVER'S SAFETY COURSE THAT IS NOT YET REFLECTED ON MY DRIVING RECORD.

- I UNDERSTAND I CANNOT TAKE THE DRIVERS SAFETY COURSE IN LIEU OF PAYING THE FINE IF
- 1. I AM ACCUSED OF SPEEDING 25 MPH OR MORE OVER THE POSTED LIMIT OR 15 MPH OR MORE IN A SCHOOL ZONE. (DRIVER'S SAFETY COURSE APPLIES ONLY TO MOVING VIOLATIONS)
 - 2. MY CITATION REFLECTS THAT I WAS IN A "CONSTRUCTION ZONE" "AND WORKERS PRESENT".
 - 3. I AM A HOLDER OF A CDL.
 - 4. I DID ILLEGALLY PASS A SCHOOL BUS.

YOU MUST RETURN THIS LETTER AND A COPY OF THE CITATION POSTMARKED NO LATER THAN THE APPEARANCE DATE SHOWN ON THE CITATION.

IF YOU FAIL TO RESPOND TO THIS CHARGE BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE OF VIOLATE PROMISE TO APPEAR MAY BE FILED. WARRANTS WILL BE ISSUED FOR YOUR ARREST AND ADDITIONAL FEES ASSESSED. YOU MAY ALSO BE DENIED THE RIGHT TO RENEW YOUR DRIVER'S LICENSE. THE MINIMUM FINE FOR A VIOLATE PROMISE TO APPEAR IS \$250.00 PLUS COURT COSTS.
